**ORDER**

**Sub: Looking-after Arrangement in the grade/post of Executive (DGM) in Telecom. Operation Stream –regarding**

(A) Shri O. P Sharma, (Staff No. 33536), TDM, Jhalawar is hereby transferred & posted as DGM, Banswara-TD, in the interest of service.

(B) Further, in pursuance of BSNL CO, ND Letter nos. 412-13/2013-Pers.I (II) dated 22-03-2013, 412-13/2013-Pers.I dated 01-04-2013, 412-13/2011-Pers.I dated 29-04-2013, the AGM/DE, mentioned in enclosed Annexure, is hereby ordered to look after the current duties of DGM on standalone basis, temporarily for a period not exceeding 179 days, with immediate effect. This arrangement is purely temporary and is likely to be terminated without notice at any time.

2. The above look after arrangement will be subject to Vigilance Clearance. No separate order will be issued in this regard.

4. The service in higher Grade under this arrangement will not count for any benefit in matters of future promotion, seniority. This looking after arrangement will not confer any extra remuneration / fixation benefits.

5. The executives ordered to look after the duties of DGM through this order will exercise the functional powers (Administrative and Financial) attached with the post.
