The DPC process for officiating promotions from SDE to DE/AGM has been delayed extremely. Every time the only one reply that we are waiting clarification from BSNL HQ will now not serve the purpose.

Vindictive attitude of a DPC member has been sheltered. This association had already complained that how the same DPC member had inversely affected the process firstly by ignoring the meetings secondly by raising an irrelevant reference. The officer should be removed from such sensitive duties.
