ORDER

Sub: Looking-after Arrangement in the grade/post of Executive SDE(T) –regarding

In pursuance of BSNL CO, ND Letter Nos. 412-13/2013-Pers.I (II) dated 22-03-2013, 412-13/2013-Pers.I dated 01-04-2013, 412-13/2011-Pers.I dated 29-04-2013, the JTOs(T), mentioned in enclosed Annexure, is hereby ordered to look after the current duties of SDE(T), temporarily for a period not exceeding 179 days, with immediate effect. This arrangement is purely temporary and is likely to be terminated without notice at any time.

2. In case any vigilance/disciplinary case is pending / contemplated against any of the executives listed in enclosed annexure or any punishment like stoppage of increment is current, this looking after arrangement should not be given effect to and the fact should be intimated to this office immediately, by the controlling officer.

3. They will automatically stand posted to the substantive post i.e. JTO(T) in the same SSA/ Unit in which they are posted on looking after arrangement on completion of 179 days or by any other orders issued by this office or before retirement/ voluntarily retirement, whichever is earlier. No separate order will be issued in this regard.

4. The service in higher Grade under this arrangement will not count for any benefit in matters of future promotion, seniority. This looking after arrangement will not confer any extra remuneration / fixation benefits.

5. The executives ordered to look after the duties of SDE(T) through this order will exercise the functional powers (Administrative and Financial) attached with the post.
