

- 2. The promotion orders are subject to the condition that the executives are free from vigilance angle. All the concerned SSAs are therefore requested to ensure that the vigilance status of the above mentioned executives working in their concerned SSAs before implementing the promotion. The executives should also be free from any disciplinary/vigilance case of type referred to in DOP&T OM No: 22011 /4/91-Estt (A) dated 14.09.1992 or any currency of punishment. In such cases, he / she should not be promoted and the matter should be should be reported to this office immediately. In cases where any of the above mentioned conditions are met resulting in non promotion of the executive, the same may be immediately brought to the notice of this office with details.
- 3. On promotion to the grade of Accounts Officer the pay of the executives will be fixed as per the instructions issued vide OM No: 1-50/2008-PAT(BSNL) dated 05.03.2009 read with letter no. 400-61/2004-Pers.I dated 18.01.2007 and further modifications issued from time to time if otherwise applicable.
- 4. If the executives are on leave/training, they shall be promoted after return from such leave/training.
- 5. Any other discrepancy, viz., variation in the name of the executive, staff No, category etc shown in the order may be brought to the notice of this office with supporting documents for rectification of records.
- 6. The leave, if any requested by the executive who are under transfer, should not be granted under any circumstances by the SSA(s) where they are presently working. The executive may apply for leave to the Competent Authority at the new place of posting, who will sanction the same if it is justified in the normal course.
- Posting of executives (s) to the sensitive/non-sensitive posts should be done by the SSA as per prescribed norms circulated by DoT and O&M branch of BSNL Corporate Office from time to time.
- 8. TA/TP may be regulated as per the guidelines issued by BSNL vide letter No: 19-27/2002-L&A (Part) dated 15.04.2004 and further modifications from time to time.
- Necessary charge report may be sent to all concerned including Dy.Manager (SEA), CO BSNL, New Delhi and Accounts Officer (CR), Circle Office, Jaipur.
