On promotion to the grade of Accounts Officer the pay of the executives will be fixed as per the instructions issued vide OM No: 1-50/2008-PAT(BSNL) dated 05.03.2009 read with letter no. 400-61/2004-Pers.I dated 18.01.2007 and further modifications issued from time to time if otherwise applicable.
- 4 If the executives are on leave/training, they shall be promoted after return from such leave/training.
- The leave, if any requested by the executive who are under transfer, should not be granted under any circumstances by the SSA(s) where they are presently working. The executive may apply for leave to the Competent Authority at the new place of posting, who will sanction the same if it is justified in the normal course.
- Any other discrepancy, viz., variation in the name of the executive, staff No, category etc shown in the order may be brought to the notice of this office with supporting documents for rectification of records.
