Sub: Local Officiating Promotion from SDE to DE - Request for change/ Modification of certain orders.

Respected Sir,

In continuous of our letter dated 1-10-2009, We are constrained to bring to your kind notice that so many senior executive's has been transferred while ordering local officiating promotion order from SDE to DE issued vide Memo no. STA/8-11/GA/LO/2008/114 dated at Jaipur the 07.10.2009.

The BSNL Corporate Office issued instruction/guidelines time to time for transfer & posting on local officiating promotion, making looking after arrangement. The matter was discussed to GM (A) & also brought to your kind notice vide letter no. AIBSNLEA /RAJ./2009- 10/4 dated 1st October' 2009.

The BSNL Corporate Office clearly mentioned in the office memorandum on dated 01/07/2004 & again clarified the issue to address CGMT, Gujrat Telecom Circle on dated 31/08/2009(Copy enclosed) that the senior most officers should be retained in the same SSA, subject to availability of vacancy. If all the senior most officers could not be accommodate in the same SSA due to non availability of adequate number of vacancies, rest junior officer may be posted to other SSA.

In the above orders four senior executive's of sriganganagar has been posted to different SSA and four others have been brought in from different SSA's out of these four executive's two are going to retire with in a year or two.

Similarly our Branch Secretary at Bundi has been posted at Chittorgarth on promotion where as an executive's from Jaipur has been posted to Bundi. The Branch Secretary has got immunity from transfer; hence he may retain at Bundi on promotion.

I hope as a gesture of good will and for maintaining harmony in relation with association the Branch Secretary will be retained at Bundi along with other four senior executive's of sriganganagar SSA.
