We would like to draw your kind attention to the discrepancies/deviations in transfer and posting orders. The transfer orders are issued by the management due to administrative exigencies. As a prevalent practice in this regard pers. section of circle office first issued the transfer order of executives and thereafter recognised/support association office bearers who claim immunity from those order were reviewed as per REA rules-2014(eg. Ref. No.1,2).

However in the latest transfer and posting orders pers. section does not transfer the office bearers of the recognised executive association instead they issued the order of immunity to the office bearers for the particular period. (eg. Ref. No.3).

Sir, I request you kindly issue the transfer order of office bearers of recognised association as per prevailing practice then thereafter executives claiming immunity from transfer should be considered. It is requested that the transparency should be maintained by your good office as done in the past.
