### Sub: Local officiating promotion from TTA to JTO cadre.

- 1. The 61 TTAs who have successfully completed JTO Phase I training listed in Annexure-I are promoted locally, purely on temporary basis to officiate in the cadre of JTO for a period of not more than 180 days or till regular incumbent joins whichever is earlier and posted as shown against each.
- 2. They will automatically stand reverted on afternoon of 01-03-2014 or on joining of regular incumbent or by any other orders issued by this office or till retirement/voluntary retirement, which ever is earlier. No separate order will be issued for reversion.
- 3. This local officiating promotion is purely temporary and will not entitle any claim to them for regular promotion to JTO cadre.
- **4.** Before giving local officiating promotion, the following conditions may kindly be checked that: -
  - (i) There is no vigilance/disciplinary/CBI case pending against any official.
  - (ii) Punishment of any kind is not current.
  - (iii) The official is not under suspension.

In such case, if any, the fact may be reported to this office immediately and the local officiating promotion may not be given.

- 5. SSA/Unit Heads must ensure the relieving of official for joining their new assignment on officiating promotion not later then 11.09.2013 positively & report compliance by Fax. Non- relieving of any official will be personal responsibility of the SSA/Unit head.
- 6. In case official is not willing to accept the officiating promotion, a clear-cut unconditional refusal letter may be taken from official and a consolidated list of such officials along with their refusal letters must be submitted to this office by 20.09.2013 positively. Such officials will be debarred for officiating promotion for 1 year in accordance with the BSNL HQ letter no. 19-27/2002-L&A (Pt) Pers. II dated 01.07.2004.
