## **ORDER**

- Sub: Posting on Promotion of the Executives SDE (Telecom) to the Executives AGM/DE of Telecom Operation Stream in the IDA scale of Rs. 29100-54500/- on purely temporary and adhoc basis.
- A. Looking after arrangement in the grade/post of Executive (AGM/DE) in Telecom Operation Stream issued vide this office letter No. STA/8-11/GA/LA/2013-14/38 dated 05.07.2013 in respect of the Executives SDEs (Telecom), listed in Annexure-1 is hereby <u>terminated with immediate effect & posted to the substantive post i.e. SDE(T) in the same SSA/ Unit in which they are posted on looking after arrangement.</u>
- B. Further, In pursuance of BSNL Corporate Office, New Delhi letter No 412-12/2013-Pers.I dated 19-07-2013 & dated 23-07-2013, the Executives SDEs (Telecom), listed in Annexure-2, are hereby promoted to Executive AGM/DE of Telecom Operation stream in the IDA scale of Rs. 29100-54500/- on purely temporary and ad-hoc basis and posted to the SSA/Unit as shown against their name(s) as per enclosed list at **annexure-2**.
- 2. The officers would not have any claim for their seniority in AGM/DE Grade of Telecom Operation Stream based on this ad-hoc promotion. Their seniority will be determined with reference to their basic seniority in the substantive grade of Executives SDE (Telecom).
- 3. The officer (s) shall not be promoted to the higher grade by the concerned SSA/Units in case:
  - (i) Disciplinary/vigilance case is pending.
  - (ii) The officer is under the currency of any penalty.
  - (iii) The officer is on deputation to TCIL etc.
  - (iv) P.O. not issued, due to any reason.
  - (v) If, the seniority No or Staff No. or the Category is different that indicated.
  - (vi) Ad-hoc promotion orders already issued earlier by DoT/BSNL.
  - (vii) Due to any direction from Hon'ble Court/CAT for not effecting the promotion to an individual.

All cases covered under the above clauses may be forwarded to this office within 15 days from the date of issuance of this order from BSNL Corporate Office, New Delhi for taking appropriate action.

- 4. The representations regarding non inclusion of the name of any of the officer senior to those included in this list may be forwarded to this office within 15 days for taking appropriate action.
- 5. All the promoted Executives are required to join their promotion assignment within a time period of 40 (forty) days. The SSA/ Unit Head concerned may ensure that the station of posting order in respect of the officers are issued in time and such officer are relieved accordingly so as to enable them to join the assignment within a prescribed time period of 40 days from the date of issue of this order from BSNL Corporate Office, New Delhi.

In case, the officer concerned failed to join his promotional assignment within the prescribed time period of 40 days, he should not be allowed to join the post thereafter. In such an event the promotion order shall become inoperative and the matter shall be reported to this office for further necessary action. Further, no request for the modification of promotion / posting orders shall be entertained after the expiry of the 40 (forty) days period.



- The leave, if any requested by the officer, who is under transfer, should not be allowed. If, any 6. officer desires leave, he can apply for leave to the Competent Authority only after joining the new posting and the Competent Authority will sanction leave, if it is considered justified, in the normal course.
- 7. The date on which the above order are given effect to, may be intimated and charge- reports duly verified by the Head of the concerned SSA/ Unit may also be sent to this section & all concerned.
- In case, any of the officers on assumption of the charge of Executive AGM/DE Grade on his 8. promotion, is subjected to the disciplinary proceedings within a period of one year, the detail of such officers be forwarded to this office for taking further action as per the provision made in the "BSNL Conduct, Discipline and Appeal Rules 2006" on the subject and amendments thereof from
- 9. In case any of the executives is under transfer to any others Circle/SSA/unit as SDE, he may be directed to join as Executive AGM/DE on promotion in the Circle/SSA/unit where he has been ordered for his transfer in the grade of SDE. Details of such cases be forwarded to this office.
- 10. The promotion orders are subject to the outcome of various court cases pending in Hon'ble Courts.
