Request of Shri Arvind Kumar Tyagi, JTO, Jaipur-CO(Under Transfer), HR No.200204292, regarding change of posting SSA from Bhilwara to Ajmer at his own cost and request is enclosed herewith for your kind order on the grievance please. The details mentioned in the request are genuine (*severe sickness of his mother*). We have already requested for cancellation of his transfer on the basis of his service at Barmer for more than 6.5 years in previous cadre and his posting just three month back at Jaipur during his promotion to JTO. Things are waiting for consideration till now.

The official has now requested for change of his posting stations from Bhilwara to Ajmer at his own cost, as already many JTOs with higher stay have been accommodated near to Jaipur while he had been posted at a longer distance which is clear injustice to the official. Mother of the official is severely sick and he is the only son and he has to look after his parents. One transferred JTO from Bhilwara has entitled for immunity in transfer hence technically his substitute is already available at Bhilwara.

The issue is important and needs immediate favour. We would therefore, request you for your kind order on the grievance. I am sure that priority shall be given to the case.
