Sub: Abnormal delay by field units in the payment of stipend arrear due to the revision of the IDA pay scales w.e.f. 01.01.2007 and remittance of EPF amount -Reg.

Respected Sir,

As per BSNL Corporate Office Letter No. 16-1/2003-Trg dt. 26.06.2015 endorsed by Circle Office Jaipur vide letter no. Rectt/XI-97/TTA-OS/2014/64 dated 07.07.2015 (Copy Encl.), DR JTOs/JAOs are entitled for the stipend arrear of their induction training period w.e.f. 01.01.2007. But in spite of the passing of more than 6 months period the payment have not been made so far to concerned DR JTOs/JAOs by the respective SSAs. in spite of the clear orders from BSNL Corporate Office.

Also As per the BSNL Corporate Office Letter No. 500-85 / CA-II / BSNL / EPF / 2011 / Vol.VI dt. 17.09.2015 (Copy Encl.), BSNL recruited employees are entitled for the EPF coverage for their pre-induction training period. As per the said orders the employee's share of the said contribution will be borne by BSNL and no deduction on this account shall be deducted from the salary of the employees.

Therefore, it is requested that necessary instructions may kindly be issued to all the Heads of field units for making an early payment of stipend arrear due to the revision of the IDA pay scales w.e.f. 01.01.2007 and remittance of EPF amount and the issue may please be kept under observation to ensure that the concerned DR JTOs/JAOs have been given their legitimate benefits, which have already been ordered by BSNL Corporate Office.
