In pursuance of Telecom Directorate letter No. 37-3/95-SEA dated 15-1-1996, the following Sr.TOAs qualified in JAO Part-I examination and Sr. Accountants etc are promoted as Junior Accounts Officers on purely temporary and local officiating basis against short term vacancies, for a period not exceeding 180 days or joining of regular incumbent or the date of their retirement whichever is earlier, with effect from **11-8-2009** or the date of their actual joining of the promoted post whichever is later and posted in the offices mentioned against each. All conditions of local officiating promotion will be applicable to them. This local officiating will neither count for their seniority in the promoted post nor will bestow any right upon them for their permanent absorption in the promoted post.
